ELIGIBILITY

- This Registration is ONLY for the residents of Langkawi, Kedah:
 - who is a holder of Malaysian National Registration Identification Card ("**NRIC**");
 - who is eighteen (18) years old or older;
 - who resides in Langkawi, Kedah; and
 - with NRIC registered address in the District of Langkawi, Kedah.

CONDITIONAL REGISTRATION

- The Applicant shall be required to use the Registration and Agreement Form downloaded and printed from www.langkawiferryline.com ("**Website**"), owned and operated by Langkawi Ferry Line Ventures Sdn Bhd ("**LFLV**").
- Each Registration is unique to any single NRIC with multiple registration is NOT ALLOWED and any violation of this condition shall cause adverse effect to the holder of such NRIC, including but limited to, being barred from further or future registration permanently and no appeal whatsoever shall be entertained by LFLV.

- The Applicant shall fill in the downloaded and printed Registration and Agreement Form and shall bring the duly filled-up Registration and Agreement Form and his/her original copy of NRIC to the office of LFLV for execution by the Applicant before a LFLV's witnessing officer and for verification of the Applicant's NRIC by a LFLV's verifying officer.
- This registration is subject to the following terms and conditions:
 - This Form shall be signed by the Applicant before any authorised officer of LFLV; and
 - The original copy of the Applicant's NRIC must be tendered for verification by any authorised officer of LFLV during the submission of this Registration.

ACTIVATION

- Unsuccessful Application will be notified via email and any appeal on such decision shall be filed within **fourteen (14) days** from the date of such notification and no appeal shall be entertained thereafter.
- The successful Applicant may activate his/her online account with the Website by using the given Username and the Default Password.
- The Default Password shall only be used once by the successful Applicant during his/her first logging into the Website and the Applicant shall be required to change his/her computer-generated Default Password with his/her new password of his/her choice ("**New Password**") in order to enhance security.
